1. General Information

4. Pricing and Payment

All prices are listed in Euros (€) and include VAT unless stated otherwise. Prices may change at any time without notice. We accept secure payment via iDEAL, Credit Card and PayPal.

Payment must be received in full before your order is processed and shipped.

Currently all our software services in the mobile app and back-end are free. We reserve the right to modify the costs of services at any time. However, we will keep providing a freemium model in which the basic functionality (i.e. safe non-optimised charging) of the charger can always be used free of charge.

5. Data Protection and GDPR Compliance
